Product Description: Pressbooks is a book content management system which produces multiple formats: webbooks, ebooks, print-ready PDF, and various XML flavours. It is built on top of WordPress Multisite and makes significant changes to the default WordPress admin interface, web presentation layer, & export routines. It is typically installed with a suite of complementary plugins and themes which extend the tool's default publishing capabilities. Pressbooks is free software, released under the <u>GPL v3.0 or later</u> license.

Evaluation Methods Used: Testing was conducted by the Inclusive Design Research Centre at OCAD University. Testing was done on the following browsers: Firefox 133, Safari 18.2, and Chrome 131. Tools used for testing include: NVDA 2024.4 screen reader, VoiceOver screen reader, WebAIM Wave Toolbar, aXe (The Accessibility Engine), Nu HTML checker, TPG Colour Contrast Analyzer.
